Motion by Anderson, seconded by Schneider, to rescind the motion of February 27, 2003 concerning the provisions of \$10,000 to each secondary school in Plymouth County effective July 1, 2007. Motion Carried.

Motion by Schneider, seconded by Anderson, to contract with Kim Norby to meet with Department heads in preparation of future needs of IT in Plymouth County with a cap of 40 hours at \$85.00 per hour. A final report will be presented to the Board of Supervisors. Motion Carried.
