Motion by Anderson, seconded by Kass, to approve the August 9, 2011 agenda. Motion Carried.

Motion by Guenther, seconded by Loutsch, to approve the August 2, 2011 minutes. Motion Carried.

Motion by Anderson, seconded by Kass, to approve the canvass of the City of Hinton Special election held on August 2nd, 2011 as presented:

For the public measure "Shall the City of Hinton, Iowa issue its notes in an amount not exceeding the amount of \$980,000 for the purpose of constructing, equipping and furnishing a new public safety building, including police, fire and ambulance facilities?"

There were one hundred twenty-eight (128) votes cast as follows:

FOR the question, there were one hundred five (105) votes.

AGAINST the question, there were twenty-three (23) votes.
